Council takes aim at empty buildings, absentee owners

Gladewater has too many buildings languishing in limbo in the hands of absentee and apathetic owners, Mayor Brandy Flanagan says, and progress demands action.

"I want us to be strict on this," she told council members, city staffers and residents last week: "I don't want to do anything that's going to hinder people that want to come into Gladewater and do business the right



way, but I for sure want to make it difficult on people that want to come in and hold buildings hostage and continue to make our community look blighted when we have businesses trying to get in here."

The rest of the council seemed eager to act as well, directing City Hall employees to get the ball rolling on a committee that will reshape local ordinances to curtail the growing number of empty properties and unresponsive owners – soonest, before an anticipated influx of business interest tied to Toll 49.

"There are substantial businesses that would benefit our town so much," Flanagan said, frustrated, "but we can't get property owners to contact us back to be able to have the conversations because at the end of the day they don't want to sell the building."

Re-zoning will be part of the discussion, along with possible guidelines on how long a building can remain for sale without some degree of intervention.

"One thing that's happening, some people are buying property, make a little money upfront and just letting it stay vacant as a tax write-off," councilman Rocky Hawkins agreed.

It makes Gladewater look 'closed' to new businesses, Flanagan said, at a time when TxDOT's road project will drive interest.

"We will have businesses that before never looked at us, certain chains, that will come in now just because of Toll 49. These things have got to be addressed because we've got to have places for these businesses to come in."

In other business during the council's monthly meeting June 20:

• the group weighed comments supporting and opposing a beer and wine at Chad's (809 E. Broadway Ave.) before unanimous approval of a Special Use Permit for the business;

• approved new regulations to mitigate "aggressive panhandling" and limit permit-free solicitation to local organizations, requiring an application and \$500 fee from outside groups;

• authorized City Manager Charlie Smith to advertise for bids for work on Guy Street in light of drainage issues apparently caused by lax rules under previous city administrators;

• took no action on the Gladewater ballpark following more discus-

sion in closed session but authorized use of ARPA grants funds for the purchase of property on Hwy. 271 for a new lift station;

• adopted updated rules for manufactured housing – find more coverage at GladewaterMirror.com.

Independence Day celebrated locally July 3 at Lake Gladewater

July Fourth is a day of celebration across the United States. The Fourth of July commemorates American independence and millions of people throughout the country celebrate the day with family and friends.

Gilmer's annual Independence Day fireworks and air show is also set for July 3rd at the Yamboree Event Center. Gates open at 7:30 p.m., with the air show scheduled for 8:30 p.m. and the fireworks show at 9:15. Admission is free.

While some celebrations like Gladewater's and Gilmer's are community based, others are must-see events for any patriot. The following are some of the more noteworthy Fourth of July celebrations that will entertain millions in person or on television this year.

• Washington, D.C.: It should come as no surprise that the capital of the United States hosts an especially awe-inspiring Fourth of July celebration. In addition to a concert featuring well-known musical acts on the National Mall, the festivities in the nation's capital are marked by a fireworks extravaganza that will impress anyone seeking a unique way to celebrate the holiday.

• Boston: Estimates suggest roughly half a million individuals take in the Fourth of July festivities in Boston. A hotbed of patriotism during the American Revolutionary War, Boston embraces that spirit each July with a celebration on the city's Charles River. The Boston celebration spans two days and includes a popular performance by the Boston Pops.

GISD locks in budget for FY2025, tax rate pending

Total revenues and expenditures increased by 4 percent in Gladewater ISD's \$22 million financial plan for Fiscal Year 2024-2025.

Notably, GISD trustees did not adopt a tax rate June 24 for the new budget – it's not uncommon as the district (and other taxing entities) await certified values from local appraisal districts, due later in July.

In other business Monday, the board signed off on exemptions tied to the district's switch to a four-day week and rubber-stamped policy updates handed down by the state legislature.

The balanced budget adopted for the current FY2024 totals \$21,078,340. The FY25 budget comes in at \$21,915,710, a year-to-year increase of \$837,370.

Chief Financial Officer Candy Keller walked trustees through the finalized budget ahead of unanimous approval. During the requisite public meeting, Keller noted the revenues were right in line with projections.

"I felt we had good, solid numbers," she said. Notably, "The number we get from our taxpayers (\$6,346,022) is now lower than the number we get from the state (\$15,219,688), which is opposite where we were several years ago."

The curriculum line item in the budget stands out, increasing 135 percent on paper – one position will now utilize operating expenses, previously covered by sunsetting ESSER funds.

District of Innovation Co-Chair Opal Smith laid out the necessary state policy exemption that will allow GISD to begin the school year Aug. 6 on a four-day schedule.

Electric demand could double by 2030

The chief of the Electric Reliability Council of Texas told state lawmakers recently that the state's power demand could nearly double in just six years. The reasons: population growth, new requests for grid connections, and a rise in requests from data centers and other heavy users.

ERCOT chief executive officer Pablo Vegas told lawmakers the grid operator has sharply increased its prediction of power demand in coming years, The Texas Tribune reported.

"All of that is putting together a picture of a very significant, different demand growth that is forcing us to really re-think how we're looking at planning to make sure we can meet those needs and continue to deliver on the expectations of all Texans," Vegas told lawmakers.

In a post on X (formerly Twitter), Lt. Gov. Dan Patrick said the Legislature should "take a close look" at data centers and crypto operations.

"We want data centers, but it can't be the Wild, Wild West of data centers and crypto miners crashing our grid and turning the lights off," he wrote.

STAAR scores in math, science decline

Texas student scores in math and science showed marked drops in science comprehension, according to the Texas Education Agency. The 2024 results show declining math and science scores across all tested grade levels.

Only 34% of elementary and middle-school students met or mastered grade-level science, a drop of 5.7 percentage points from last year. Math scores also dropped slightly.

"Pandemic-induced disruptions to learning exacerbated students' difficulties in mastering fundamental math concepts, TEA Commissioner Mike Morath said. "As a result, we must keep our foot on the gas to intensify efforts in providing targeted interventions and research-based education strategies to ensure that students obtain necessary foundational skills and concepts and achieve the desired academic outcomes not only in math but across all subject areas."

Happy Independence Day friends and neighbors! May your holiday sparkle with memories.


Insurance Rates

While prices for virtually everything have risen in recent years, few items have rivaled the spike in insurance prices. Texas rates for home and auto policies have surged, putting a strain on households and businesses alike.

Private passenger auto rates rose by 23.8% in 2022 and 25.5% in 2023. Reasons include more expensive cars and higher costs for repairs. Parts are also hard to obtain (particularly when body work is required), and labor costs have escalated. The result is that insurers are raising rates as they attempt to bounce back from massive losses over the past few years (claims and expenses from home and auto policies were \$1.10 for every \$1.00 in premiums in 2023).

Homeowners' average rates rose 10.8% in 2022 and 21.1% in 2023. Again, the cost of home repairs is a major reason for the increase. Construction costs are higher than in the past, as are the prices for materials and labor.

petition is compounding the problem, reducing choices and placing upward pressure on prices. A growing number of people are opting to only partially protect their homes or forego insurance altogether, which could prove financially disastrous. Although some amount of auto liability coverage is mandated by Texas law, higher prices will inevitably increase the number of uninsured motorists on the road, thus escalating risk exposure and costs for carriers.

The Texas Windstorm Insurance Association (TWIA) provides wind and hail insurance to coastal homeowners and businesses that cannot obtain it elsewhere. TWIA

Weather events and climate phenomena are also a factor, particularly as they intersect with population dynamics. Texas has long been adding new residents faster than other states, and one outcome has been the appearance of thousands of homes in areas prone to hail, hurricanes, wildfires, and tornadoes. For example, a hailstorm north of Dallas-Fort Worth 10 or 15 years ago might have fallen primarily on fields and grassland where there are now rapidly growing cities and highend housing developments. Many communities along the Gulf Coast have also seen substantial growth, thus magnifying the costs of storms. The number of weather events generating losses of more than a billion dollars has skyrocketed.

Some insurers are reducing their exposure in Texas and other areas prone to weather calamities. Less com-

manages a trust fund and has mechanisms to raise additional reserves if needed. As with many carriers, it relies on reinsurance (essentially insurance for insurers), the price of which has also soared.

Looking ahead, the pace of increase will likely ease, but premiums will unfortunately remain above historical patterns and settle into a "new normal" – an unavoidable consequence of a growing economy and population in a geography characterized by more frequent and expensive weather events. Stay safe!

"It balances the length of the fall and the spring semester to align with summer school, internships and different things like that," she said. A second variance adapts standard 10-month / 187-day teacher contracts for the truncated schedule: "The benefits would be reduced teacher contract days with no effect to teacher salaries," consequently increasing the daily rate of pay for teachers, enhancing recruitment and improving morale.

Trustees also approved an exemption tied to transfers – per updated policy, on the rare occasion a student's behavior warrants suspension, out-of-school placement or expulsion, the district will not be required to honor the pupil's enrollment for the standard one-year minimum.

IF THE BLIND FOLLOW THE BLIND

There is a lot said in the Bible about "following." To Peter and Andrew, Jesus said: "Follow Me." (Matt. 4: 19). In Hebrews 13: 7. Speaking of elders, the writer said: "Whose faith follow." In 1 Cor. 11: 1, Paul said: "Be ye followers of me." There is nothing wrong with following others as long as others are following the Lord. Problems come when we "blindly" follow some man. "*Hey, he yelled, why didn't you put out your hand when you stopped?*" "*Why should I*?" was the calm reply. "*I'm home in my own garage*!"

The moral: Follow others, but not blindly. Imitate them as they imitate the Lord. Follow their faith if it is based on the Word of God. (*Rom. 10: 17*). Ask yourself: "*Who do I follow, and why*?" Think on these things.

Grill safely on Independence day

Plenty of people can be found working their grilling magic year-round. But the vast majority of people do the bulk of their grilling over the summer and this July 4th, when warm temperatures contribute to a relaxed atmosphere that makes outdoor cooking and dining that much more appealing.

The relaxing nature of summer can make it easy to overlook safety, particularly when grilling. However, the right safety measures when cooking over an open flame can prevent home fires and other accidents that can cause injury and even death. In recognition of the many things that can go wrong when grilling, the Federal Emergency Management Agency and the U.S. Fire Administration offer these simple fire safety tips that every grillmaster can keep in mind as summer grilling season hits full swing.

• Only use a grill outside. Grills should never be used indoors, and that includes in garages with the doors open. Before lighting a flame, make sure the grill is at least three feet from siding, deck rails and eaves.

• Establish a safe zone around the grill. A three-foot safe zone around the grill can decrease the likelihood that pets will run into and potentially tip over the grill. Kids can be taught to respect this zone as well so they avoid being burned.

• Open a gas grill before lighting it. Charcoal grills, hybrid grills and smokers cannot be lit unless the lid is lifted. That isn't the case with gas grills, but gas grills should never be lit with the lid closed. If a gas grill is lit with its lid closed, gas can build up inside and that could cause an explosion. Even if there's some summer rain falling, open the lid on a gas grill before turning the ignition switch.

• Keep an eye on the grill at all times. It's tempting to walk away from a grill while food is cooking, but someone should always be tasked with staying close to the grill. If cooks must walk away, ask another adult to stay close to the grill until you return. All it takes is a few seconds for a fire to start.



• Clean the grill regularly. Regular cleaning of the grill is both healthy and safe. Cleaning helps to ensure the cooking surface is clean and unlikely to cause food poisoning. But a grease-free grill also poses less of a fire hazard than one that hasn't been cleaned.

• Let coals cool before discarding them. Coals from the grill should be given ample time to cool before they're removed from the grill and discarded.

• Remember to turn the gas valve to the off position after cooking. When cooking with gas grills, cooks must remember to turn the valve to the off position once all the food has been cooked. Simple safety measures can ensure summer grilling season goes off without a hitch.

· John Adams, a Founding Father of the United States and the second president in the country's history, felt Americans should celebrate their independence from Great Britain on July 2. That's because the Continential Congress voted for independence on July 2, 1776. However, the Declaration of Independence was not approved for two more days, thus making July 4 the day to celebrate America's independence.

Gilmer man gets life+40 years

Ray Reppond to life imprisonment, and two 20-year prison terms, after he pleaded guilty days earlier to sex-related charges involving female children, said Upshur County District Attorney Billy Byrd's office.

Details of the cases, said Byrd and his office manager, Lisa King, were as follows:

In a case involving a 10-year-old girl, Reppond, 60, of Gilmer, received the life term for aggravated sexual assault of a child, and a 20-year term for indecency with a child. after being named in a single indictment on both charges.

In the other case, the defendant drew the other 20-year term for indecency with a child involving a 13-year-old girl.

Jurors also fined Reppond \$30,000 apiece on all three charges.

The jury was chosen in Judge Dean A jury in Gilmer last week sentenced Allen Fowler's 115th District Court June 10 before Reppond pleaded guilty June 12, and elected to have the jury sentence him. Jurors deliberated fewer than 20 minutes June 18 in the one-day trial in deciding to assess the maximum prison terms and maximum fine in each case.

> Byrd and Assistant District Attorney Michael F. Northcutt Jr. prosecuted the case. Gilmer attorney Matthew Patton represented Reppond, who will appeal the case.

> Byrd said he sought the maximum sentences in each case, citing testimony that "these children will never forget what happened...They have been sentenced to a life term" themselves. Patton asked for no particular sentence, but to "weigh all the facts," Byrd added Tuesday.



How to handle fireworks safely

Warm weather generally translates to more time spent outdoors. That means more barbecues, days spent poolside, trips to the beach, and even camping excursions. This time of year also inspires people to celebrate. What better way to signal the party has started than with fireworks?

Fireworks traditionally are part of large celebrations, such as national holidays or grand opening events. Many individuals also take it on themselves to set off fireworks during block parties or other neighborhood gatherings. Though fireworks are awe-inspiring, they're also dangerous, which is why it's best to leave them to the professionals.

The U.S. Consumer Product Safety Commission reports that fireworks-related injuries and deaths in the United States have risen by roughly 25 percent in the last 15 years. In 2021, nine people died in accidents involving fireworks, and 11,500 were injured.

"The safest way to enjoy fireworks is to watch the professional displays," said Alex Hoeh-Saric, chair of the CPSC.

Three-quarters of fireworks injuries occur the weeks before and following the July 4th holiday in the United States.

Fireworks can injure any part of the body, but burns to the hands and fingers, trunk, and arms are the most commonly affected areas. Injuries to the eyes, including blindness, also may occur.

Sparklers are not necessarily safe, either. The CPSC reports that 1,100 injuries result from sparklers each year.

As fireworks become widely available, it's imperative that individuals follow these crucial safety tips when using them.

• Never allow children to play with or ignite any type of firework, including sparklers.

• Keep a bucket of water or garden hose nearby to extinguish fires or sparks.


• Only buy and use fireworks if they are legal.

• Light fireworks one at a time in accordance with manufacturers' instructions.

• Choose a field or area free from trees and other obstructions, far away from spectators to light fireworks.

Never use fireworks while impaired by alcohol or drugs.
Never point or fire fireworks in the direction of other people.

• Do not place any part of the body directly over fireworks when lighting a fuse.



July 4 pool party safety urged

Americans gather in backyards across the United States in celebration of the nation's independence each July. Festivities often include delicious foods cooked on the grill, music, laughter, and, if there is a pool in the yard, hours of splashing around.

Pools are great places to cool off from the hot sun. But pools also can be dangerous. According to the U.S. Consumer Product Safety Commission, drowning remains the No. 1 threat to children. Previous July 4 drownings should serve as sober warnings to those planning to celebrate in and around a pool this Independence Day. Simple precautionary measures can save lives.

• Never leave a child unattended in a pool or around any body of water no matter how small, even for a minute.

• Teach children basic water safety.

• Avoid overloading the pool with too many boisterous swimmers, especially if adults, older kids and young kids are in the water. Small children can quickly get lost in the fray.

• Avoid swimming if you have been consuming alcohol.


• Designate a lifeguard, whether it's a hired, certified professional, or someone who has taken on the task and will keep eyes fixed on the pool at all times while swimmers are present.

• Establish rules and enforce them. Prohibit diving into shallow water and running around











the slippery edge of the pool.

- Learn how to administer CPR to both children and adults.
- If a child goes missing, look for him or her in the pool first.

• Minimize the use of pool floats that can obscure the view of the pool floor when there are many swimmers present.

- Keep a phone handy at all time. Promptly call for emergency services if the need arises.
- Ensure everyone immediately exits the pool if thunder is heard or lightning is seen.

• Turn off the filter pump while guests are swimming, particularly to protect against entrapment on pool drains or pipes.


• The American Association of Pediatrics advises against allowing infants and toddlers in hot tubs. Older children should not be in a hot tub for more than 20 minutes at a time.

• Be sure the water chemistry is balanced in pools and spas so that swimmers are not irritated by the chemicals and the water is sanitary. Also, keep in mind that swim diapers are not foolproof. Check youngsters often so that waste does not end up in the pool.

These are just some pool safety tips to keep everyone protected during July 4 festivities or anytime a pool is used.

Prepare pets for Fourth of July festivities

Many people are eager for Independence Day celebrations in early summer. There is much to be excited about, as festivities often begin in the afternoon with barbecues and pool parties, and commence late at night after fireworks shows that light up the night sky. Update identification

Be sure prior to any July 4th events that pets are wearing collars with current identification information. If an address or phone number has changed since the last time you updated microchip records, be sure to check the account is current.

Be careful with alcoholic drinks

Party hosts typically serve beer, wine and cock-

tails. Alcoholic beverages have the potential to poison pets, says the ASPCA. Animals can become very intoxicated, severely depressed or go into comas if they drink alcohol. Keep spirited drinks well out of reach.

Check with the vet

Many pets are prone to anxiety from loud noises, such as thunderstorms and fireworks, and lots of commotion — something that occurs in spades come July 4th. Some veterinarians recommend a small course of anti-anxiety medication or a sedative to help pets cope with the stimuli.

Create a quiet space

Allow pets to ride out the day in their comfortable, quiet and cozy retreats. If necessary, create a space in an interior room. Cover the pet crate with a blanket and offer favorite toys or bedding to create a soothing environment.

Place notes on doors and gates

While it's best to keep pets in a locked room away from the fray, some pets like to social-

ize with guests and are not bothered by noises. However, alert guests with notes posted on doors and fence gates to check to make sure pets are not trying to escape behind them. All doors should be closed firmly when entering or exiting.

Pick up debris

Firework debris can rain down on properties even if you were not shooting off the fireworks. Curious pets may pick it up or eat it, which runs the risk of an upset stomach or even an intestinal blockage. Check your yard before letting pets out to play.

<u>Keep an eye on the grill</u>

Pets can be opportunists, and those burgers and chicken drumsticks smell delicious to pets. Pets that get too close to the grill can become injured. And if pets eat leftovers, they may end up with digestive distress or even be poisoned by foods that are toxic to cats and dogs. Pets need to be protected during summertime parties like Independence Day celebrations.
